A lot has changed in the two years since Maui Health System was formed with the goal of assuming the management of Maui Memorial Medical Center, Kula Hospital and Lanai Community Hospital.

We are no longer a state hospital; we are a community hospital. We have new leadership with a focus on improving the quality of care and expanding the depth and breadth of services available right here on Maui.

Facing a huge shortage of doctors on Maui, Maui Memorial has committed to bringing additional specialists and primary care physicians to our community—and has recently recruited two neurosurgeons to provide vital care for patients with strokes, aneurysms, spine surgery and other emergencies. We're looking forward to bringing on more physicians in 2019 so that we can provide state of the art care on Maui.

After many years of functioning as very independent entities, the Maui Memorial Medical Center Foundation has taken the important step of fully integrating with the hospital. This has allowed the Foundation to align all of its fundraising efforts with the hospital's highest priorities, so that the Maui community can focus its support on what Maui Memorial needs most.

Through this partnership, and thanks to the generosity of our community, the Foundation recently purchased more than \$1 million in technology for the hospital's neurosurgery suite. Having these tools available is essential to attracting the best physicians possible for the program and giving them the equipment, they need to save lives.

We are truly grateful to each and every one of our donors, physicians, nurses and staff who are helping Maui Memorial become the world-class hospital all Maui residents and visitors deserve. With your help, we will continue to grow and provide exceptional, life-saving healthcare for years to come.

A LIFELINE FOR PATIENTS



THE PATIENT

Dr. Warren Youngquist, 74, was driving on Hana Highway when he became so lightheaded, he thought he might pass out behind the wheel.

After he pulled over safely, his wife slipped into the driver's seat and drove straight to Maui Memorial Medical Center, where Warren immediately underwent diagnostic tests. The results: he was experiencing ventricular tachycardia, a life-threatening heart rhythm disorder in which the lower chambers of the heart beat too fast.

"I want to go back to the mainland," Warren remembers telling the doctor, who responded, "Warren, if I put you on that plane, you're going to be dead." Instead Dr. Colin Lee performed a coronary angiogram immediately, which showed that Warren's arteries were clear. He concluded that Warren needed a cardiac ablation, a specialized procedure to disable parts of the heart that trigger an abnormal rhythm.

"Dr. Lee stayed with us for more than an hour and explained everything in detail," Warren says. "He was an advocate for my well-being, and just an amazing physician."

Warren was transferred to Honolulu, where he underwent two ablation surgeries and had a defibrillator implanted to correct his condition and then returned home.

A retired orthodontist and part-time Haiku resident, he credits the doctors and nurses at Maui Memorial for their quick and caring response. "They were there to make sure I got the very best care, that nothing was overlooked from the emergency room and cardiac doctor to the radiologists. They were all excellent. I could not have been treated better anywhere."

THE HEALTHCARE PROVIDER

When Dr. Colin Lee first saw Warren Youngquist, he knew he had to act quickly. Warren was passing out and complaining of chest tightness. Tests showed he was experiencing ventricular tachycardia, a racing, irregular rhythm in the lower chamber of the heart.


"Because it could have been a heart attack causing Warren's symptoms, it was important to immediately determine if that was a cause or not," says Dr. Lee, an interventional cardiologist.

Warren was moved to Maui Memorial Medical Center's cardiac catheterization lab, where Dr. Lee performed a coronary angiogram to check for blockages. When the procedure showed that his arteries were clear, Dr. Lee knew he could stabilize Warren to be transported to a hospital in Honolulu for a specialized surgery on the electrical systems of his heart.

Maui Memorial's team of cardiologists and heart surgeons are a lifeline for patients like Warren, who need emergency cardiac care on-island, Dr. Lee says. "We feel we have a top-notch cardiac program at Maui Memorial. For the last eight years, there's never been a break in the coverage we've provided at the hospital. Our mission has been to treat all Maui residents and visitors suffering acute heart attacks and other cardiac emergencies in the best way possible, without delay."

On the morning of February 6, 2018, Kihei resident Scott Walsh collapsed as he was getting out of bed. Although he felt normal, his left leg was strangely weak. "I said, 'I'm okay,'" recalls Scott, age 66. "My wife said, 'You're not OKAY – I'm calling 911.'"

At Maui Memorial Medical Center, Scott learned he was having a stroke. Knowing that every second counts in treating a stroke, doctors took immediate action to save his life. They first administered a "clot-buster" medication. When tests showed the blood vessels in his brain were still blocked, Scott underwent surgery. Doctors inserted a catheter into his femoral artery, and performed a procedure known as a mechanical thrombectomy to remove blood clots from blood vessels in his brain.

Scott spent two days in the hospital and then returned home. Three weeks later, after physical therapy, Scott, who owns Ki-Hana Nursery in Kihei, had almost completely recovered. He could go back to work and get back to his favorite activities, like throw-net fishing, walking on the beach, and diving.

Scott credits his remarkable recovery to the fast treatment he received at Maui Memorial. "They had everything they needed to do the operation," he says. "If I'd had to go to Oahu or the Mainland, I'd be in a wheelchair for the rest of my life—or I'd be dead."

Minutes after Scott Walsh arrived at the hospital, Dr. Cordia Wan's phone rang.

"The Emergency Department doctor called me immediately," says Dr. Wan. A neurologist at Maui Memorial Medical Center. "Over the phone, we formulated a plan for the patient." Scott was reporting sudden-onset weakness on the left side of his body. "It was a stroke," says Dr. Wan. "A clot had gone into a blood vessel into the brain, blocking blood flow to that part of the brain."

Scott was administered tPA, a medication for thinning blood in some stroke patients. Then neurointerventional radiologist Dr. Turgut Berkmen performed a procedure to remove the clot.

When Dr. Wan saw Scott, he was out of the procedure room and in the intensive care unit. Dr. Wan managed Scott's blood pressure and used MRIs, CT scans and lab tests to determine the cause and extent of the stroke.

After two days, it was determined that Scott could go home.

"This was a great outcome," Dr. Wan says. "In medicine, it takes a team: from the paramedics who responded quickly and brought him to the hospital, to the doctors and nurses who administered life-saving care as soon as he arrived. He was incredibly lucky that we have a primary stroke center here on Maui so that he didn't need to be transferred to another island, because every second counts. Our team has a fine-tuned process to get stroke patients the care they need as soon as possible. We're all incredibly lucky to have access to this high degree of medical care in the middle of the Pacific."

A visit to the Intensive Care Unit was not on Betty Leis's plans for celebrating her 90th birthday, but just a few weeks after marking such an important milestone, that's exactly what happened.

Betty had fallen at home and was brought to Maui Memorial Medical Center's Emergency Department. Images taken by the hospital's state-of-the-art CT scanner showed a bleed in her brain. To closely monitor her injury, she was admitted to the ICU.

"They took a lot of precautions with my mom because they knew she'd had a similar injury a year earlier," says Betty's son, Stephen Leis. "They were prepared for a situation that could have been worse."

Betty was impressed by the care she received in the ICU, especially her nurse, Josh Masslon. "They take really good care of you," she says. "On the second day I was there, he'd been to the library and he brought me things to read on what had happened to me. He really takes an interest in his patients."

Two days after she was admitted, a follow up CT scan showed that the bleeding had stopped, and Betty was released from the hospital. She was glad to get home so that she could spend time with her seven children, 13 grandchildren, 11 great-grandchildren, and her first great-great-grandchild.

Stephen appreciates the excellent care his mother received at Maui Memorial. "People really care," he says. "They take time to answer your questions, and they have a passion for what they do. I think that makes a big difference."

Josh Masslon is used to seeing people at their worst. As an intensive-care nurse at Maui Memorial Medical Center, Masslon helps care for some of the sickest patients in the hospital.

"When people are in the hospital, especially the ICU, they're so vulnerable," he says. "We have to be cognizant of that, and try to make people feel comfortable and safe in that environment."

When Josh met Betty Leis, she'd been admitted to the hospital for neurological monitoring after a fall. He was struck by her curiosity, sense of humor, and positive attitude. "We always try to educate patients—that's part of our job as nurses—and she was just so open to hearing what I had to say. And she's in her 90s! It was inspiring."

Intensive-care patients are often discharged to other floors of the hospital, so nurses don't always have a chance to say goodbye or follow a patient's recovery. That's why Josh says the best part of caring for Betty was the opportunity to wheel her out of Maui Memorial's front doors when she was discharged. He says, "It's always great when you see somebody go home."
